# **Grand Knight's Report**

## **Brother Knights,**

Brothers, I hope that you like the new meeting agenda and the shorter meetings. It is Supreme's intention to make the meetings shorter and a good use of your time. If you have not attended a meeting in a while, please consider attending a meeting, meeting a fellow Brother Knight, and participating more in our Council event and activities.

The month of February is dedicated to the **Holy Family**. Between the events that marked Christmas and the beginning of Christ's public life, the Church has seen fit to recall the example of the Holy Family. This year the first 16 days of February fall during the liturgical season known as **Ordinary Time**, which is represented by the liturgical color green. The remaining days of February are the beginning of **Lent**. The liturgical color changes to purple — a symbol of penance and the sorrow of a contrite heart.

Beginning on Ash Wednesday, February 17, **Lent** is a season of reflection and preparation before the celebrations of Easter. By observing the 40 days of Lent, Christians replicate Jesus Christ's sacrifice and withdrawal into the desert for 40 days. Lent is marked by fasting, both from food and festivities.

We will continue to practice social distancing and wear masks (or other facial covering). As always, please do not attend a meeting or any of our events/activities if you feel ill, uncomfortable, or vulnerable. Thanks for your continued cooperation and understanding. # **New Council Meeting Agenda**

Section 124 of the *Charter, Constitution and Laws of the Knights of Columbus* requires each subordinate council to hold at least two regular meetings each month. One is a Council meeting for all members. The purpose of this meeting is to build fraternal spirit, to share information, to strengthen formation in the faith, and to present matters that require the vote of council members.

The other monthly meeting is an Officers' Planning meeting. The purpose of this meeting is to plan programs, develop budgets, pay approved bills, prepare motions, discuss new ideas, and deal with other necessary matters. Council officers, directors, and chairpersons are required to attend this meeting. This meeting is open to any council members who wish to attend.

Council meetings are a key part of a Knight's experience. It is imperative that these meetings respect the valuable time of our members. Outdated, wasteful practices must be replaced by relevant, motivating meeting agendas that fully engage attendees.

The Fraternal Mission staff did an extensive review of council meetings including a survey with feedback from nearly 55,000 members. The outcome of this careful research is a new set of guidelines and agendas for council meetings that reflect what Knights want and need. Care should be taken, however, to preserve the intent and purpose of standard agenda items and to ensure meetings do not exceed one hour.

Are councils required to hold two meetings per month? Yes. Council meetings and Officer Planning meetings are both required each month.

Are we permitted to keep aspects of the former meeting structure that have been removed? A council may vote to retain aspects of the former meeting structure; however, careful consideration should be given to the value of these elements as well as the time involved. All meeting agenda items should be completed within one hour.

Can council votes be held at an Officers' Planning meeting? No. Council votes can only be held at Council Meetings.

**Do the Treasurer and Financial Secretary both speak during the Financial Report of the Council meeting?** In general, the Financial Report will cover only the status of council accounts managed by the Treasurer. The Financial Secretary may be asked to provide a report on other timely matters, or in response to a question from the members.

**What is included in the Financial Report?** The Financial Report should be limited to a status of the council's bank accounts, including aggregate receipts and expenditures, funds raised from events, and charitable contributions by the council. It should assure members that adequate funds are available for upcoming commitments.

Does the Financial Secretary report on council standing, dues collection, etc. only at the Officers' Planning Meeting? The Financial Secretary provides a complete and full report at the Officers' Planning meeting. Members interested in the details of council finances should attend the Officers' Planning meeting where more in depth financial discussions take place.

When and at which meeting should a member raise a new topic or issue? A member should notify the Grand Knight, prior to any meeting, of a new topic or issue he would like to raise. This allows the Grand Knight time to add the item to an upcoming meeting agenda. Suggestions and new topics should be addressed at the Officers' Planning meeting. However, time sensitive or emergency issues may be raised during the New Business portion of a Council meeting.

Why was the council chamber setup modified? The prior setup facilitated exemplification ceremonies during the meetings themselves. Now that 'Initiations' are no longer part of the meeting agenda; the modified chamber setup is more appropriate. The officers and directors who will be giving most of the presentations are all seated in front of the members. The members are all facing the front of the room where the speakers will be giving their remarks.

# **Sugar Land CCBS, Inc.**

Sugar Land CCBS, Inc. was formed years ago for insurance and taxation purposes. Because the CCBS, Inc. has the beer license from the state of Texas, county of Fort Bend, and city of Sugar Land, we are obligated to follow strict guidelines as set forth by the TABC (Texas Alcohol Beverage Commission). Individual council members **can NOT** just do as they wish or simply help themselves to the bar facility. Failure to follow proper TABC guidelines and procedures puts the Sugar Land CCBS, Inc. at risk of losing the beer license.

# **Unauthorized Destruction of Property & Supplies**

It is imperative that only authorized individuals (Columbus Club representative or KC Council 4204 Grand Knight or his representative) should go through property and supplies on the KC Council premises for determination BY the appropriate parties what is still needed or what can be discarded. NO ONE should be trashing or removing supplies or property without FIRST checking with the authorized individuals who use or need these items. Just because you do not need certain supplies or property does NOT mean someone else either does not need or use them. This is simply a matter of respect and common courtesy for other users. Let them determine if the items are no longer needed or useful. Basically, it is up to the appropriate authorized users to determine and discard supplies that they no longer need or use. #### ST. THERESA '40 DAYS FOR LIFE' PRAYER LINE SPRING 2021

'40 Days for Life' begins Feb. 17 and lasts until March 28, 2021. We at St. Theresa are responsible for manning the prayer line at Sharpstown.

Jesus calls us to action. God spits out those who are lukewarm. Prayer lines are up Mondays and Thursdays from 8:30 am until 2:30 pm. Perhaps you and some friends can carpool and pray the rosary for an hour or two. Lawn chairs on the grass are acceptable. Mothers can bring their children with toys or balls to play with on the grassy area behind the prayer line. Perhaps you can talk to friends at the parish after Mass or during the week and ask them to participate. Spread the word. Presence makes all the difference. The women will almost never come up to you for help. Theirs is a personal decision made in the car as they watch you praying with your signs. Your success is their driving away rather than going in for the abortion. Without the presence of our parishioners they have no hope. 70+ % of women who have had abortions say they wanted their child but no one was there for them when they needed help. Up to 75 % of women with appointments for an abortion on a given day will drive away due to the positive presence of a prayer line. Stand before God at your judgement with a life saved on the resume of your soul.
