# **Grand Knight's Report**



Worthy Chaplain Fr. David, Worthy Associate Chaplain Fr. Jose, Worthy Officers, Brothers and Ladies,

The month of August, though usually slow brought us some new opportunities to serve our parish and our community. First, in early August we had a great turnout of over 35 parishioners for our first Pro-Life Rosary of the fraternal year, thanks Dave Wleklinski for being the leader of the Rosary and our Pro-Life Chairman. Then we had a few projects to be done at the hall as well as cooking for our Fourth-Degree meeting. We then had a great

turnout of over 70 Knights, Catholic Daughters and their families at our Family Dinner Night on August 20th that included a special appearance by Fr. David. These were all great opportunities to serve, celebrate and worship but the events that really stood out was our support at the Mamie George Catholic Charities facility in Richmond. Brother Knights and ladies answered the call not once, not twice, not three times but four times last month when the need was great. We started out with just 5 Knights the first week, then 9 Knights and one lady, then 13 Knights and 3 ladies then finally 8 Brother Knights. (Please see the pictures in this newsletter). I am so proud to be your Grand Knight but prouder yet to be able to serve with you at all these endeavors. We stressed at the beginning of this fraternal year that we as a council would be focusing on the seven corporal-works of mercy, and this is truly a great start.

As we focus on the month of September and what's ahead, we find that the call for help has never been louder than it is right now. We as a council will continue to serve every Thursday out at the Mamie George Catholic Charities facility until they tell us they no longer need the help. On Thursday September 2<sup>nd</sup> we had 9 Knights and 1 lady show up to help. If we had not been there, they would have only had 2 volunteers when normally it takes 12 or more. They are serving close to 1000 families per week with Tuesday and Thursday being their busiest days with over 350-400 each day.

We are also hearing the cries for help from our neighbors in Louisiana after the devastation of Hurricane Ida. I am working with the Knights of Columbus Disaster Relief Chairman in Louisiana right now to help coordinate a relief effort that will require us to deliver donated supplies down to the Houma area. More details will be coming out on this very soon.

# **Knights and Ladies in Action!**



#### WHAT IS THE COLUMBUS CLUB?

What is the Columbus Club?

Why do we need a separate group of Knights that manage our property and pay the utility bills?

To begin one must understand that the Knights of Columbus conducts its charitable and fraternal missions through an extensive network of subordinate councils, which are prohibited from owning real property. Subordinate councils are unincorporated associations holding charters from the Knights of Columbus or otherwise approved by the Board of Directors of the Knights of Columbus. Subordinate councils have the discretion to choose a suitable location to conduct their activities in light of the mission and identity of the Knights of Columbus. The Knights of Columbus cannot hold title to any property nor generate wealth, but the Knights of Columbus can raise money for charity and good works in their community.

Home Corporations are deemed separated entities in which individual members of some subordinate councils form a corporation outside of the control of the Knights of Columbus for the purpose of buying real property and owning buildings where their councils can establish a permanent home. This why our Columbus Club was formed.

The name of our home corporation is The Columbus Club Association of Sugar Land, Texas. I will refer to it as "the Club". This corporation holds title to the property and everything that our Council uses and/or has. The Club pays the bills such as electric, gas, etc. Like any corporation the Club has a board of directors. One of these directors is your Grand Knight, which is mandated. In the Club there are 12 elected directors besides the Grand Knight. The directors serve three-year terms. Four are elected or reelected each year in June. This way only 1/3 of your directors are new yearly.

The Club is the group that leases the hall/annex, can sign a note for improvements on the hall/annex, buy supplies, fish fryers, and so forth. The club has property tax exempt status, so it does not have to pay county, school, state, or city taxes.

The Club created a third organization that is named the SUGAR LAND CCBS INC. I will refer to it as "CCBS". The officers of the CCBS report to the Club. The CCBS leases the bar area and holds all profits from all alcohol sales. The CCBS pays the Club for the use of the facility with the profits from the alcohol sales. Neither the Club nor the CCBS can retain any profit per their bylaws. All profit, with some minor exceptions, earned must be given back to the 4204 council.

So, you see it is a big circle. All profits are paid to the Club which pays the bills. Any money left over is paid to 4204 which uses it for charity work. The Club and the CCBS exist under the direction of the 4204. In fact, the President of the Club reports to the Grand Knight.

All members of Council 4204 are members of the Club. 4204 elects the Club directors as described above. The Club directors take office on July 1 of each year just like your council officers. The 13 Club directors then elect a president, vice-president, secretary, and treasurer from their ranks as directors. The Club President appoints a Maintenance Manager, Leasing Manager, and Hall Manager that report directly to him. Any 4204 member can be named to these three manager positions. However, in most cases the appointees will be a current or past Club Director, but it is not mandatory.

The Club directors also elect the president, vice-president, secretary, and treasurer of the CCBS. The CCBS officers do not have to be a Club director, but in most cases will be. The Club treasurer cannot be the CCBS treasurer.

Hopefully, you now know what the Columbus Club is and does. Come to the next Columbus Club meeting which is the <u>first Tuesday of every month</u> and get involved. Think about running for a Club Director position or filling a director position when it is vacated. The four new 3-year term directors are elected annually in June.

#### **SOLID SCIENCE or MADISON AVENUE HYPE?**

Every black cloud has a silver lining and the Roe v Wade Supreme Court Decision's was a beginning of the collection of scientific data about Abortion. It would take decades of this collection to have sufficient data to begin to draw valid conclusions. Science always provides insight that is useful in the medical field. As to this statement, science has by now collected decades of data from women who had abortions and later in life tried to have a family. The bulk of this data has been reported by Gynecologists and Women's General Practitioners as well as birthing doctors to the CDC and the AMA.

The conclusions to date are as follows:

"Its only a clump of cells" (All animals and plant life are only a clump of organized, specialized cells including any adult human being.)

The next time you are told one of these Madison Avenue one liners demand the scientific study that it is derived from. They will be the one's backing away as they are exposed to truth.
