Exposing Susan G Komen-Planned Parenthood Link

# Susan G. Komen Foundation groups are preparing for annual breast cancer runs across the country.

- raise awareness on the link between abortion and breast cancer, breast cancer cases have risen
   40 percent since abortion was legalized in the 1973 Supreme Court case Roe v. Wade.
- the breast is an organ that is not mature at birth and SGK officials appeared to be surprised to
  learn that the breast does not become fully mature until after 32 weeks of pregnancy. As a result
  of that state of development, interruption of pregnancy via an abortion before 32 weeks leaves

- Komen's funding Planned Parenthood made no sense because abortions are one of the biggest causes of breast cancer. Dr. Joel Brind, a professor at New York's Baruch College
- In 1996, Brind and other researchers conducted analysis of all the major studies done in the field to that time. They concluded that women who had an abortion before their first term child had a 50% increased risk of developing breast cancer while women who had an abortion after their first child sustained a 30% increased risk.
- significant documentation showing that local Komen affiliates have given money to Planned Parenthood. Pro-Life Waco
- Komen affiliates awarded \$38.4 million in grants to support community outreach programs in 2003. That figure includes 21 grants to their local Planned Parenthood chapters totaling more than \$475,000.the Aspen, Colorado affiliate gave Planned Parenthood a \$12,887 grant last December. former Komen public relations director Kristin Kelly

## KC Insurance update

#### Only having "through work" insurance doesn't work
